Immediately on their reporting at Guwahati Office they shall be sent for the Medical Fitness Test and thereafter have to move for their Induction Training. The candidates will be allowed to join subject to being found medically fit by our authorized hospital. Therefore the candidates are to come prepared accordingly.

At the time of reporting for joining, the candidates are also required to bring the following documents:-

- i) Two copies of Diploma or provisional Diploma Certificate showing the class/division awarded by the State Board of Technical Education together with the documents showing aggregate percentage of marks obtained in each year/semester along with copies thereof, duly attested by a Gazetted Officer. The Originals are also to be brought for verification.
- ii) Two copies each (duly attested by a Gazetted Officer) of the certificate in support of your Date of birth, community, etc. The caste certificate should be exactly as per the proforma enclosed. The Originals are also to be brought for verification.
- iii) Relieving letter from your present employer, if serving or undergoing training in a Government/Semi-Government department or undertaking.
- iv) Character certificates from two different persons not related to you from amongst the following :-
 - a) Gazetted Officer of Central or State Government;
 - b) Member of Parliament/State Legislature or Municipal Bodies;
 - c) District Magistrate or Sub-Divisional Magistrate;
 - d) Tahsildar or Deputy Tahsildar;
 - e) Principals of the recognised Educational Institutions last attended.

v) The Service Agreement Bond, duly signed by you and the person standing surety for you as per item "D" of the enclosed terms and conditions of appointment. Guidelines for executing Service Agreement Bond is enclosed. You are advised to study the guidelines carefully before executing the Bond. You may note that you shall not be allowed to join without the Service Agreement Bond completed in all respects.
