Candidates are required to get the following verified in their NSR profile at their own cost before joining or within 03 months of joining, failing which the engagement shall automatically be terminated without assigning any reason/notice whatsoever:*

- Personal details like Identity, Bio-metrics (fingerprints)*
- Essential Qualification i.e. - Post Graduation/Graduation/Diploma/Relevant Degree (as applicable)*
- Previous employment/experience information*

*Upon joining, candidates shall be required to provide permission to POWERGRID to view their profile in NSR.*

Further the candidates having score more than or equal to qualifying marks although are in selection panel, however the Offers of Appointment shall be issued purely on the basis of order of merit of the candidates as well as number of vacancies in respective category. If any candidate fails to report on the stipulated date for document verification, pre-employment medical examination as per our Advt.
