The candidates may please note that their specialization in Human Resources/Personnel Management / Industrial Relations should clearly be mentioned on their PG degree certificate or they should be able to produce the certificate clearly showing the same.

The candidates are required to bring following documents in original and one self-attested photocopy of each:

- i. Date of Birth Certificate - Matric / Birth Certificate (wherein DOB mentioned)
- ii. Valid Photo Identity proof (Driving License/PAN card/Passport/Voter ID/Aadhaar Card)
- iii. Qualifications Certificate along with Mark sheets of all years/ semesters of following examinations
 - a) Matriculation
 - b) Intermediate
 - c) Bachelor degree certificate
 - d) Post graduation certificate as prescribed in our advertisement dated 07.02.2018
 - e) Any other qualification
- iv. Proof of Norms adopted by the University/Institute to convert CGPA/OGPA/DGPA into percentage
- v. Service/experience certificate, if any
- vi. Caste certificate, if applicable (in case of SC/ ST/ OBC-Non Creamy Layer) in prescribed GOI format from Competent Authority.
- vii. Declaration regarding non-creamy layer status i.r.o. OBC candidates in the prescribed format
- viii. Disability Certificate, if applicable (in case of Persons with Disability) in prescribed GOI format issued by Competent Authority/ Medical Board.
- ix. Certificate in the prescribed format issued by Competent Authority in respect of J&K Domicile/ Victims of Riots, if applicable.
- x. J&K domicile-cum-age relaxation certificate in support of age relaxation being claimed by the candidate
- xi. Candidates working in Govt./PSU are required to submit "No Objection Certificate"
- xii. A copy of Online Application submitted

Further, Second Class rail fare by the shortest route from the aforementioned address to the place from which the candidates has actually travelled whichever is nearer, will be reimbursed, subject to submission of proof of travel in form of railway ticket /bus ticket. No other expense will be reimbursed. No travel expenses are admissible to candidates travelling if the travel distance from place of travelling to place of test is within 30 Km.

Candidates may please note that they have to make their own arrangements for stay at Jammu in case the Computer Skill Test may spill over to the next day.

Note: **In case any candidate fails to bring any of the above mentioned certificates/ documents or found ineligible as per eligibility criteria specified in the detail advertisement, their candidature shall be summarily rejected and he/she shall not be allowed to appear for Computer Skill Test. Hence, shortlisted candidates must ensure their eligibility for the subject post before proceeding for the test. Further, such candidates will also not be eligible for to & fro travel fare.**
