The cut-off marks for the subject post for UR category are 97.50/170. The candidate may note that the cut-off marks are the **marks of the last candidate empaneled in 1:5 ratio of advertised vacancies as mentioned in Point No. 7 under Selection process of our above said advertisement**. Further the candidates having score more than or equal to cut-off marks although are in selection panel, however the Offers of Appointment have been issued purely on the basis of order of merit of the candidates as well as number of vacancies. If any candidate fails to report by the stipulated date for pre-employment medical examination and subsequent joining, his/her candidature shall be summarily withdrawn and cancelled without any further notification. Thereafter, Next candidate in waiting panel shall be called for appearing for document verification and other formalities.
