

NOTIFICATION FOR THE CANDIDATES WHO HAVE APPLIED FOR THE POST OF DIPLOMA TRAINEE (ELECTRICAL/CIVIL) & JR. OFFICER TRAINEE (HR) ADVERTISED BY POWERGRID, NORTHERN REGION TRANSMISSION SYSTEM-II, RHQ, JAMMU ON 07.02.2018

Attention is hereby invited of all the candidates who have submitted their online applications for the post of Diploma Trainee(Electrical/Civil)/ Jr. Officer Trainee(HR)(as applicable in their case) advertised by POWERGRID, NRTS-II, RHQ, Jammu vide Advertisement dated 07.02.2018, to the following:

1. Selection Test for the aforesaid posts shall be conducted through Computer Based Test (CBT) on **25.03.2018 (Sunday)** at Delhi NCR, Chandigarh, Mohali & Jammu.
2. The time, Schedule and Centre is being allocated and mentioned in the Admit card which may be downloaded along with instructions for the Selection test. The Admit Card download link shall be active **w.e.f 13.03.2018(Tuesday)** onwards and the same may be accessed by the candidates by logging-in to **login tab** available against this advertisement hosted on our website through their respective login ID and password generated at the time of application.
3. Candidates are advised to carefully read the instructions pertaining to CBT given along with the Admit cards and may practise online for acclimatizing with CBT on the Mock test link <https://g01.digialm.com:443//OnlineAssessment/index.html?1470@@M8>
4. The eligible candidates are being allocated venues at the above said locations keeping in view the proximity of their residential addresses to the best possible extent and availability of centres. **However no request for change of centre or venue shall be entertained under any circumstances and the candidates have to compulsorily attend the selection test at the allocated venue only.**
5. The question paper administered in the CBT shall be bilingual (English/Hindi). Candidates may attempt the question paper either in English or Hindi. The candidates shall have the facility of scrolling between English and Hindi versions of question paper; however, in case of any disparity/ discrepancy in the Hindi version, the English version of the question paper shall be treated as Final and shall prevail.
6. SC/ST/PwD candidates are required to download TA claim form, fill in their bank details (same details as filled in online application form while applying for the post) and bring it on the day of selection test along with the proof of journey in form of tickets for reimbursement. **No TA shall be admissible without bank details or proof of journey.**
7. Candidates are advised to keep themselves abreast with latest updates being loaded on this website by logging from time to time.

Candidates may please note that they are being allowed to appear in selection test provisionally on the basis of details mentioned by them at the time of application. Candidates may note the following:-

- i. **The candidates, who applied for the post of Jr. Officer Trainee (HR) and whose PGDM / MBA certificate doesn't mention the details of specialization, are being allowed provisionally for the Selection Test, subject to the condition that they shall be treated eligible only if their specialization is in Human Resource/ Personnel Management/Social Welfare. Candidates are advised not to proceed for the test if they do not meet the requisite criteria for the subject post as laid down in advertisement dated 07.02.2018.**
- ii. **The qualification acquired by candidate for appearing for selection test should essentially be Full-Time/Regular. Qualification acquired through distance mode is not allowed. Any candidate having acquired essential qualification through distance mode is advised not to attend the Selection test.**
- iii. **Candidates claiming age relaxation of J&K domicile are being allowed to appear in the Selection test provisionally subject to submission of age relaxation certificate in format prescribed by Govt. of J&K for availing the said relaxation in age.**

Any candidate who is not meeting the laid down criteria as mentioned in the above said advertisement is not eligible for the post and he is advised not to appear in the selection test. In case such candidates still attend the selection test, their candidature is liable to be rejected at later stage without any notice. All the candidates are advised to check their eligibility before proceeding for test.
