Attention is hereby invited of all the candidates who have submitted their online applications for the post of Field Supervisor (Electrical) advertised by POWERGRID, NRTS-II, RHQ, Jammu vide Advertisement dated 23.01.2019, to the following:

1. Selection Test for the aforesaid posts shall be conducted through Computer Based Test (CBT) on **29.03.2019(Friday)** at Jammu.
2. The time, Schedule and Centre is being allocated and mentioned in the Admit card which may be downloaded along with screening test and CBT instructions **w.e.f 15.03.2019(Friday)** by logging-in to login tab available against this advertisement through respective login ID and password generated at the time of application.
3. Candidates are advised to carefully read the instructions pertaining to CBT given along with the Admit cards and may practise online for acclimatizing with CBT on the Mock test link <https://g01.digialm.com:443//OnlineAssessment/index.html?1470@@M12>
4. The question paper administered in the CBT shall be bilingual (English/Hindi). Candidates may attempt the question paper either in English or Hindi. The candidates shall have the facility of swiching between English and Hindi versions of question paper; however, in case of any disparity/ discrepancy in the Hindi version, the English version of the question paper shall be treated as Final and shall prevail.
5. SC/ST/PwD candidates are also required to give their bank details in their login for the purpose of TA claims. No TA shall be admissible without bank details. Further, SC/ST/PwD candidates shall also download TA claim form and bring it duly filled in on the day of selection test along with the proof of journey in form of tickets.
6. Candidates are advised to keep themselves abreast with latest updates being loaded on this website by logging from time to time.

Candidates may please note that they are being allowed to appear in the screening test provisionally on the basis of details mentioned by them at the time of application. Candidates may note the following:-

- i. **The prescribed one year post qualification experience shall be counted after the date of completion of prescribed essential qualification i.e. the duration between date of declaration of final result and date of completion of experience should not be less than 1 year.**
- ii. **Trainee period shall not be considered as experience, hence the said period shall not be reckoned for the purpose of calculating experience for the subject posts.**
- iii. **Apprentices who have completed their one year apprenticeship training have been allowed provisionally, however, if they qualify the selection test; their detailed work assignments will be verified to ascertain the relevance of their experience in line with advertised experience vide advertisement dated 23.01.2019; before issuance of final result.**
- iv. **Candidates claiming age relaxation of J&K domicile are allowed provisionally subject to submission of age relaxation certificate in format prescribed by Govt. of J&K, if they qualify the exam and call for further recruitment process.**

Any candidate who is not meeting the laid down criterion is not eligible for the post; he/she is advised not to appear in the Selection test. In case such candidates still attend the Selection test, their candidature is liable to be rejected. All the candidates are advised to check their eligibility before proceeding for test.
